The appeal was considered by the Council and it was decided to revisit the institution as per undertaking submitted by the institute.

Based on the report of expert committee revisit, the All India Council for Technical Education (AICTE), is pleased to accord extension of approval for the course(s) and intake as given below with the following conditions:-

1. The conditions imposed by the concerned university regarding its criteria for affiliation, admission and academic schedule are fulfilled as per the university rules.
2. That the State Government is in a position to provide students through central counseling as per its schedule for the current academic session, if not so the approval may be revalidated as per rules by the Council for the academic year 2003-04.
